

Centre notifies census

The Government on Monday issued a notification for conducting India's 16th decadal census, 16 years after the last census in 2011. Census 2027 will include caste enumeration for the first time since the Independence. The census will be carried out with a reference date of October 1, 2026 in the snow-bound areas like Ladakh and March 1, 2027 in the rest of the country, the notification said.

"The reference date for the said census shall be 00.00 hours of the 1st day of March, 2027, except for the Union territory of Ladakh and snow-bound non-synchronous areas of the Union territory of Jammu and Kashmir and the States of Himachal Pradesh and Uttarakhand," it said. In respect of Ladakh and snow-bound non-synchronous areas of the Union Territory (UT) of Jammu and Kashmir and the States of Himachal Pradesh and Uttarakhand, the reference date shall be 00:00 hours of the first day of October, 2026, it said.

The massive exercise, which is expected to cost the Government over ₹13,000 crore to give population-related data from across the country, will be conducted by about 34 lakh enumerators and supervisors and around 1.3 lakh census functionaries armed with digital devices. Union Home Minister Amit Shah reviewed the preparation for the census with Union Home Secretary Govind Mohan, Registrar General and Census Commissioner of India

This is the 16th census since the exercise started and the eighth after Independence, a Government statement said. According to Article 246 of the Constitution, the census is a subject listed at 69 in the Union List in the Seventh Schedule. The census is the primary source of data collection from every section of the society and a decennial activity.

The last comprehensive caste-based count was done by the Britishers between 1881 and 1931. Caste was excluded from all census operations conducted since Independence. The decision to include caste enumeration in the upcoming census was taken by the Cabinet Committee on Political Affairs chaired by Prime Minister Narendra Modi on April 30. "Considering all these circumstances, and to ensure that

our social fabric does not come under political pressure, it has been decided that caste enumeration should be included in the main census instead of being conducted as a separate survey," an official statement had said. In 2010, then Prime Minister Manmohan Singh had assured the Lok Sabha that the matter of caste census would be considered in the cabinet. A group of ministers was formed to deliberate on this subject and majority of the political parties recommended conducting a caste census. However, the previous Congress-led Government opted for a survey instead of a caste census, known as the Socio-Economic and Caste Census (SECC).

The SECC conducted in 2011 under the UPA Government did collect caste data but it was never fully published or utilised. Bihar and Telangana have conducted caste surveys in the last three

years. While some States have conducted surveys to enumerate castes, these surveys have varied in transparency and intent, with some conducted purely from a "political angle, creating doubts in society", the Government had said.

In the upcoming exercise, the provision of self-enumeration will also be made available to the people. The two-phased census will start with the first step of house-listing operation (HLO) in which the housing conditions, assets and amenities of each household will be collected. This will be followed by the second phase of population enumeration in which the demographic, socio-economic, cultural and other details of every person in each household will be gathered. Very stringent data security measures would be kept in place to ensure data security at the time of collection, transmission and storage.

Iran missile attacks on Israel kill eight

Iran fired a new wave of missile attacks at Israel early Monday, killing at least eight people, while Israel warned hundreds of thousands of people in the middle of Tehran to evacuate ahead of new strikes.

The warning came on the fourth day of the conflict, when the Israeli military claimed it had achieved air superiority above the Iranian capital and could fly over the city without facing major threats. The military has issued similar evacuation warnings for civilians in parts of Gaza and Lebanon ahead of strikes.

The warning affected up to 330,000 people in a part of

EMBASSY ENGAGED WITH INDIAN STUDENTS

New Delhi : Amid the Iran-Israel conflict, the Centre on Monday said the Indian Embassy in Tehran was continuously monitoring the security situation and engaging Indian students in Iran to ensure their safety while also relocating them to safer places in some cases.

The Ministry of External Affairs' statement read, "The Indian Embassy in Tehran is continuously monitoring the security situation and engaging Indian students in Iran to ensure their safety."

The statement continued, "In some cases, students are being relocated with Embassy's facilitation to safer places within Iran. Other feasible options are also under examination. Further updates will follow. Separately, the Embassy is in touch with community leaders regarding welfare and safety."

"ADVISORY In view of the current situation in Iran, all Indian nationals and persons of Indian origin in Iran are requested to remain vigilant, avoid all unnecessary movements, follow the Embassy's Social Media accounts and observe safety protocols as advised by local authorities," the Indian Embassy in Iran's post on X read.

central Tehran that includes the country's State TV and police headquarters, as well as three large hospitals, including one owned by Iran's para-

military Revolutionary Guard.

"At this time, we can say that we have achieved full aerial superiority over Tehran's

skies," said Israeli military spokesperson Brig. Gen. Effie Defrin. The military said it had destroyed more than 120 surface-to-surface missile launchers in central Iran, a third of Iran's total.

Israeli military officials also said fighter jets had struck 10 command centres in Tehran belonging to Iran's Quds Force, an elite arm of its Revolutionary Guard that conducts military and intelligence operations outside Iran.

The Israeli strikes "amount to a deep and comprehensive blow to the Iranian threat," Defrin said.

Iran's State-run news agency reported that State-run television abruptly stopped a live broadcast after an Israeli strike.

ED issues fresh summons to Vadra

The Enforcement Directorate has issued a fresh summons to Robert Vadra for questioning in a money laundering case linked to UK-based arms consultant Sanjay Bhandari. He has been asked to appear before the federal probe agency here on June 17 for the recording of his statement in this case that is being investigated under the Prevention of Money Laundering Act (PMLA), said officials on Monday.

Vadra, 56, was called for questioning in the case on June 10 but he skipped, saying he had flu-like symptoms on June 9 and had undertaken a COVID test as per protocol. His lawyer had then said that Vadra had no intention of avoiding summons and was ready to appear before the ED anytime before or after his travel abroad later this month. The agency is understood to have summoned Vadra to record his statement under the PMLA and subsequently file a chargesheet in the case.

The ED had questioned the businessman for three consecutive days in April in a separate money laundering case linked to alleged irregularities in a 2008 land deal in Haryana. He is being investigated in three money laundering cases by the ED. Bhandari (63) fled to London in 2016, soon after the Income Tax Department raided him in Delhi.

A UK court earlier this month refused an application filed by the Indian Government seeking permission to appeal in Britain's Supreme Court against the discharge of Bhandari in an extradition case, virtually ruling out chances of him being brought to the country to face the law.

India has nuclear edge: SIPRI

India continues to maintain an edge over Pakistan in nuclear capabilities, with the Stockholm International Peace Research Institute (SIPRI) noting that New Delhi has not only expanded its nuclear arsenal from 172 warheads in 2024 to an estimated 180 in 2025, but also made significant progress in developing advanced nuclear delivery systems. However, the more significant development lies not in the number of warheads, but in technological advancements and evolving military posture.

According to the Stockholm International Peace Research Institute (SIPRI) report, India's new 'canisterised' missiles, which allow warheads to be pre-mounted and transported more safely, could potentially carry nuclear warheads even during 'peacetime'.

If these systems are deployed with warheads, it would mark a major doctrinal shift, enabling faster launch readiness and possibly indicating a move toward a more flexible deterrence strategy. These next-generation systems may also be able to deliver multiple warheads using a single missile in the near future.

Three India-bound 787s return mid-air

In a concerning turn of events, three Boeing 787 Dreamliner aircraft bound for India were forced to return mid-air within a span of just 36 hours due to a bomb threat and technical snags, raising fresh safety concerns among air passengers and authorities. The incidents involved flights heading to Delhi, Chennai, and Hyderabad, operated by Air India, British Airways, and Lufthansa respectively. These incidents come days after an Air India Boeing 787 Dreamliner aircraft bound for London crashed in Ahmedabad, shortly after takeoff, killing 241 of the 242 passengers on board.

A Delhi-bound Air India Boeing 787-8 Dreamliner from Hong Kong returned to its airport of origin on Monday within an hour of takeoff after the pilot in command suspected a technical issue. The pilots of the Delhi-bound Air India flight, which returned to Hong Kong after nearly 90 minutes of take-off, didn't want to continue their journey after a suspected technical glitch was

detected in the aircraft. The pilot could be heard telling Air Traffic Control, "We don't want to continue further." An audio of the pilot's conversation with the Air Traffic Control has emerged where they are heard saying that they don't want to continue and return to the airport.

incident was also a Boeing 787-8 Dreamliner, the same aircraft model which crashed shortly after taking-off from Ahmedabad airport on Thursday, June 12, killing 241 out of 242 on board.

The flight, AI 315, landed safely in Hong Kong and all passengers have disembarked from the plane, the airline said in a statement, adding that the aircraft is undergoing inspection.

BJMC anniversary shrouded in grief

A year ago, the mood was celebratory as the BJ Medical College and Hospital marked its foundation day. On Monday, the scene spelt devastation and despair - families awaiting identification of their kin killed when an Air India plane crashed into the complex, medics who lost their colleagues soldiering on stoically and everywhere the ruins of what once was.

This foundation day, its 146th, will forever stand out for its stark sorrow. The BJMC, one of the oldest medical colleges in India, has been the epicentre of action following the June 12 crash, which killed 241 people on board and 29 on the ground, including five MBBS students.

While families, their faces grim with grief and anxiety, wait for DNA identification so they could claim the bodies of their loved ones, the environs reflected their state of mind.

Thick layers of soot are still deposited on its buildings, damaged as a result of the crash. On June 16 last year, many of its students and alumni had taken to social media to wish their college and alma mater a "happy birthday", but grief and chaotic

scenes are what is evident on the campus right now, as survivors and family members struggle to come to terms with the crash.

The London-bound flight AI171 — Boeing Dreamliner 787-8 — crashed moments after taking off from the Sardar Vallabhbhai Patel International Airport on Thursday afternoon, and fell onto the campus of the medical college in the Meghaninagar area, before going up in flames.

A total of 99 victims have so far been identified through DNA matching, and 64 bodies, including that of former Gujarat

chief minister Vijay Rupani who was on board the ill-fated aircraft, have been handed over to their families, officials said on Monday.

Many medical students and resident doctors had just sat for their meal at the hostel mess when the tail-side portion of the aircraft rammed into it, turning an ordinary lunch hour into a horrific nightmare.

The images of the detached tail portion of the aircraft precariously lodged near the roof of the hostel mess building, pieces of the fuselage scattered on the ground and inside buildings,

A Goan sustenance secret

The Goa Government is taking steps to preserve the old tradition of locals foraging for wild vegetables during the monsoon in the State's forests, aimed at protecting the cultural heritage and promoting sustainable food practices, officials said.

Backed by the Government's initiative, Goa assembly speaker and Canacona MLA Ramesh Tawadkar has been spearheading a campaign to create awareness about the wild vegetables, popularly known as *Raan Bhaji*, in the coastal State.

The Pramod Sawant-led Government has been promoting the campaign during the monsoon and supporting the *Raan Bhaji* festival, which will be held sometime in September this year, Tawadkar said. "In the olden days, villagers in Goa included wild vegetables

in their diet. These are organic varieties, naturally found in forest areas and untouched by pesticides and fertilisers," Tawadkar said.

"Life expectancy was higher in the earlier times. People used to consume vegetables according to seasons. There is a need to promote these vegetables today. You could say it is part of the BJP Government's

'Fit India' initiative," he said. These vegetables also have medicinal properties and are beneficial for people of all age groups, he said.

During the *Raan Bhaji* festival held in 2023 and 2024, it came to light that at least 40 different kind of wild vegetables are found in the forests of Goa, the 56-year-old legislator said.

500-year-old Banyan tree bears heritage fruits

In a significant move toward preserving Bihar's ecological and cultural legacy, the Bihar Department of Environment, Forest and Climate Change through Bihar Biodiversity Board, has shortlisted 32 trees across five districts — Buxar, Aurangabad, Munger, Jamui, and Bhagalpur — for designation as Biodiversity Heritage Trees. A senior Bihar Government officer shared that among these, 28 trees are estimated to be over 100 years old, with most remarkable being the majestic Banyan tree in Madanpur block of Aurangabad near Gaya, believed to be approximately 500 years old.

Selection of tree was made from an initial list of over 1,500 trees following rigorous field verification through various sources including the chain of

elderly people. Detailed guidelines for heritage tree identification were issued to district collectors and divisional forest officers.

Criteria included tree age (typically more than three generations), historical or mythological significance, ecological uniqueness, endangered species status, or scientific value.

Final list features a diverse range of species: Banyan (12), Peepal (6), Pakad (3), Mahua (2), Neem (2), Khirri (1), Semal (2), Gular (1), Tamarind (1), Kalpavriksha (1), Kanak Champa (1). 500-year-old Banyan tree in Aurangabad stands as the oldest among them, while remaining trees range in age from 70 to over 100

years. To foster citizen engagement and ensure sustained protection, Bihar Government has also launched a 'Bihar Heritage Tree App'. Through this digital platform individuals and local representatives can upload images and GPS-tagged details of notable trees in their locality, their district, neighborhood, panchayat, or block, along with GPS locations.

"If the information is verified and the tree is found to have unique significance, it will be considered for inclusion in the heritage list. Submissions that meet heritage criteria will be evaluated and potentially added to the official list. Nature not only sustains life but also preserves history. Some trees standing tall on the soil of Bihar are more than just trees—they are living witnesses to centuries of social, cultural, and natural legacy," added the Bihar Government official.

Punjab's Digital Creators Face Threats, Violence, and Exile Amid Rising Extremist Intolerance

A disturbing pattern of threats, violence, and moral policing is fast emerging in Punjab's digital landscape — this time not against politicians or journalists, but against social media influencers. In less than a year, at least five influencers, including four women and one couple, have either been murdered, attacked, forced to flee the country, or subjected to death threats, as extremist groups unleash a coordinated campaign to control online narratives they deem "vulgar" or "culturally inappropriate".

Their content, often humorous, bold, satirical, or promotional in nature, has made them popular across platforms like Instagram, Facebook, and YouTube. But that same success has attracted the ire of radical elements and self-appointed cultural gatekeepers who claim that such content "corrupts Punjabi youth" or "dishonors religious and community values".

The atmosphere is eerily reminiscent of the 1980s, when popular singer Amar Singh Chamkila — famed for his bold lyrics and unmatched mass appeal — was assassinated for allegedly promoting obscenity through his music. Four decades later, his spiritual successors, armed with smartphones rather than harmoniums, are now facing the same threats for expressing themselves online.

At the heart of this escalating war is a question that cuts through the fabric of freedom in the digital age: Who gets to decide what is acceptable expression? And more importantly, why are creators — particularly women — being punished for online popularity and personal autonomy?

The murder of 29-year-old Kanchan Tiwari, popularly known as 'Kamal Kaur Bhabhi', just week marked the most gruesome escalation yet, but it's far from an isolated case. From forced apologies and cyberbullying to real-world violence and exile, Punjab's influencer community is caught in a spiral of fear.

A Ghostly Murder in Broad Daylight: Kamal Kaur Bhabhi's Death

The most shocking incident so far is the brutal killing

of Kanchan Tiwari, a Ludhiana-based influencer who had built a massive online following by creating satirical and suggestive content under the name 'Kamal Kaur Bhabhi'. Known for her comedic skits and double-entendre humour, Kamal had over one million followers, lucrative sponsorship deals, and a growing personal brand. But extremist groups didn't see an entertainer — they saw a threat. Around seven months ago, Tiwari received chilling warnings from Canada-based designated terrorist Arsh Dalla, instructing her to stop making "obscene content" that allegedly misled Punjabi youth. Soon after, radical figure Amritpal Singh Mehron, claiming to lead the group 'Koum De Rakhe', also began targeting her publicly. A week ago, on June 9, Kamal was allegedly lured to Bathinda under the pretense of shooting a promotional video. There, she was murdered, and her body was abandoned in a parked car outside a hospital. Her killing sent shockwaves through Punjab's creator community and reignited painful memories of singer Amar Singh Chamkila, who was assassinated in 1988 under similar circumstances after years of threats for his bold lyrical content.

Kulhad Pizza Couple: From Innovation to Exile

From comedy to cuisine, the wrath of radicalism has spared no genre. Sahaj Arora and Gurpreet Kaur, popularly known as the 'Kulhad Pizza couple' from Jalandhar, rose to fame for their unique idea of serving pizza in traditional clay cups. Their content was widely appreciated, turning their small eatery into a viral brand. But when an alleged explicit video of the couple surfaced online, things turned dark. Extremist trolls began accusing them of "defaming Sikh identity", especially because Sahaj wore a turban. Threats followed, with demands that he remove his turban or stop posting videos altogether. Fearful for their safety, the couple approached the Punjab and Haryana High Court and were granted temporary security on November 14, 2024. Still, the mental and emotional toll proved overwhelming. By January 2025,

the couple had quietly fled to the United Kingdom — leaving behind their business, followers, and sense of safety. **Across Borders, the Hate Travels: The Joginder Bassi Attack**

Even those based abroad aren't immune. Joginder Singh Bassi, a seasoned Punjabi radio broadcaster and political commentator based in Toronto, Canada, has also come under attack. Known for his candid discussions on Punjab politics, extremism, and diaspora issues, Bassi has long drawn the ire of Khalistani supporters. In January 2025, his home was vandalized in an apparent warning. Attackers damaged his garage, prompting Bassi to publicly accuse Khalistani extremists of trying to silence his voice.

"This isn't just an attack on me," Bassi stated on-air, "this is an attack on free expression within our community". Despite registering a complaint with Toronto Police, Bassi continues to receive death threats online.

Deepika Luthra: When Apology Isn't Enough

Deepika Luthra, a fashion and lifestyle influencer from Amritsar with more than three

lakh followers, has gone from creating content to dodging danger. Initially known for humorous videos with occasional double-meaning jokes, Deepika shifted to cleaner, brand-centric content following online threats in March 2025.

She was forced to issue a public apology, which she posted on Instagram at the behest of Amritpal Mehron. But instead of peace, she received more threats — this time via email from an account claiming to represent Babbar Khalsa International, a banned terror group.

The message was blunt: stop immediately or end up like Kamal Kaur Bhabhi. Deepika has since filed a formal complaint with Punjab's Cyber Crime Cell, stating that she holds the government responsible if anything were to happen to her or her family.

Preet Jatti's Cry for Help: 'Even My Baby Isn't Safe'

Simranjeet Kaur, known online as Preet Jatti, is an influencer from Tarn Taran with no history of vulgar content. Yet she, too, is facing threats — this time allegedly for promoting astrologers. After receiving repeated calls and

videos from foreign numbers, she filed a complaint with the local SSP office. Simranjeet, a mother to a five-month-old baby, made a heartfelt appeal: "I don't even wear short clothes in my videos. I haven't promoted any astrologer in months.

Still, they say I only have two days left. Please, stop torturing me." Her video, where she folds hands and pleads for peace, has gone viral — becoming a symbol of the growing vulnerability faced by Punjab's digital creators.

A Gendered Lens: Why Are Women the Prime Targets?

A closer look at the victims revealed a disturbing gender dynamic — four out of the five targeted influencers are women. Many of them come from modest backgrounds, are self-made entrepreneurs, and use social media not only to entertain but to earn a living.

What seems to trouble their detractors most is their visibility and autonomy — women who speak boldly, dress freely, and build public personas that challenge conservative cultural norms.

Radical groups have weaponized morality to police women's bodies, voices, and

success. And in doing so, they have turned the internet into yet another unsafe space — mirroring real-world gender biases.

Digital Fame, Real-World Danger: The Shrinking Space for Expression

What began as isolated online trolling has now evolved into a systemic campaign to silence digital voices. Influencers — many without political backing, security, or institutional support — are left to navigate a dangerous terrain where fame attracts followers, and followers invite threats.

Several influencers have already begun to self-censor. Others are leaving the field altogether, too scared to continue. And those who persist, like Deepika and Simranjeet, do so under constant fear.

Despite multiple police complaints, few arrests have been made, and even fewer convictions seem likely.

The Punjab Police has remained tight-lipped, often reacting only after media coverage or political outrage. Legal experts warned that if authorities don't take a stand now, a culture of impunity will embolden more attacks.

Punjab Delegates RC, DL Backlog Clearance to Regional Authorities for Swift Public Relief

In a landmark administrative reform aimed at easing long-standing procedural hurdles, the Punjab Government has delegated the authority for clearing the backlog of Registration Certificates (RC) and Driving Licenses (DL) to regional registering and licensing authorities across the state. The move is expected to provide substantial relief to the general public, many of whom have been waiting for years to regularize their documents.

Announcing the decision, Punjab Transport Minister Laljit Singh Bhullar said that citizens can now get their old

vehicles and driving licenses digitized online and renew their documents by following a prescribed verification process.

"The lack of approvals for outdated RCs and DLs and their non-digitization had become a significant bottleneck. This decision will empower regional offices to expedite the work and provide faster services to the public," he said. As per the new guidelines, all regional registering and licensing authorities have been directed to initiate immediate clearance of backlog cases. The Minister emphasized that documents must meet conditions laid out by the Ministry of Road Transport and Highways,

with specific reference to a directive issued by the State Transport Commissioner on May 24, 2024. To ensure authenticity, a verified affidavit from an Executive Magistrate will be required in each RC and DL backlog case, certifying key details such as category, validity, issuing authority, tax status, and the accuracy of personal information. For RC entries, a physical inspection report from a Motor Vehicle Inspector, verifying chassis and engine numbers, must be uploaded online.

In addition, transfer records of vehicles across multiple owners will be digitized to maintain ownership history transparency. For DL back-

logs, verification and digitization will occur through the Sarathi software, and will require authenticated copies of licenses, birth and address proof, and the original license copy.

To maintain transparency and accountability, Bhullar said that only permanent departmental employees will be permitted to process backlog entries.

"The responsibility for any false or incorrect entry will lie squarely with the registering or licensing authority concerned," he warned. Authorities have also been instructed to submit daily reports of approvals to the headquarters in a standardized format.

With the Ludhiana West by-election set for June 19, election authorities have announced stringent restrictions to prevent external interference and ensure a transparent voting process.

Ludhiana West

To ensure peaceful and fair conduct of the Ludhiana West by-election, District Election Officer Himanshu Jain has declared a dry day from June 17 (6 pm) to June 19 (6 pm) in the 64-Ludhiana West assembly constituency and its three-kilometre adjoining area.

All country and foreign liquor vends, hotels, restaurants, clubs, and bars — irrespective of their license categories — have been strictly prohibited from selling, storing, or serving liquor during this period. The orders apply to every establishment within the revenue limits of Ludhiana West and its adjoining three-km belt. Jain emphasized that no distribution, sale, or consumption of liquor will be permitted, and any violation will attract action. All concerned authorities have been instructed to ensure strict enforcement of the directive to maintain law and order during the election process.

Dry Day Declared from Jun 17 to 19 in

to outsiders, especially those from other districts or states. Strict surveillance will be carried out by the Ludhiana Police, Excise and Taxation Department, and Food and Civil Supplies Department, who will verify guest lists, inspect marriage halls, and check vehicles at border checkpoints.

The District Election Officer stressed that political parties, candidates, and agents must be notified of these measures, and public announcements will be made to ensure awareness.

To bolster enforcement, Flying Squads, Static Surveillance Teams, and Excise officials will intensify monitoring during the final 72 hours. EVMs will be transported under CAPF protection in GPS-fitted vehicles. 66 micro-observers will monitor polling stations, and opinion or exit polls will be prohibited 48 hours prior to voting.

Haryana focuses on 'Four Es' to reduce road accidents: Anil Vij

To reduce road accidents, Haryana Transport Minister Anil Vij on Monday said that the State Government is giving special focus on the "Four Es": Education, Enforcement, Engineering, Environment, and Emergency. The transport sector in Haryana is progressing through technology and digitization, with concerted efforts to curb corruption and ensure smooth and efficient transport services for the public. Vij made these remarks while addressing the inaugural session of the two-day workshop "e-Trans 2025" on the eTransport Project, organized by the Union Ministry of Road Transport and Highways and the National Informatics Centre (NIC) in Chandigarh. He said, "Under the digital initiative, schemes are being digitized across the country, emphasizing that without keeping pace with technology, we risk being left behind globally." Speaking on the issue of road accidents, Vij emphasized the need to leverage technology to reduce accidents and save precious lives. He noted that the unprecedented increase in vehicle traffic over the past two decades has led to a worrying rise in road accidents. This not only disrupts the livelihoods of families but also causes immense pain, suffering, and financial loss. Therefore, promoting road safety is of utmost importance.

Missing Haryana model's body found in canal in Sonapat with slit marks around throat

A Haryana-based model, identified as Sheetal Chaudhry, has been found dead in a canal in the Sonapat district with her throat slit. According to Sonapat Police, the woman (Sheetal) had left her house two days ago on June 14 allegedly to shoot a music album, and a missing report was filed for her in Panipat. A man believed to be her boyfriend has been taken into custody.

According to the police, the deceased woman's sister, Neha, told them that on Saturday, she contacted Sheetal via a video call after which her phone went out of coverage. During the call, Sheetal allegedly revealed that her boyfriend Sunil was assaulting her.

On Sunday morning, the police recovered Sunil's car from a canal in Panipat district and he was reportedly rescued from the car. Sunil was taken to a hospital from where officers took him into custody on Monday.

Talking to Reporters, Ajit Singh, Assistant Commissioner of Police (ACP), Sonapat, said that Police received information that the body of a young woman was found in the canal who was later identified as Sheetal. Sheetal's family had lodged a complaint stating that

she had gone missing. "The complaint was registered at Panipat's Urlana Kalan police post, after which officers started investigating. Eventually, the body of a woman matching her description was recovered from the canal in Kharkhoda on Monday and the family identified her. We are further investigating the matter," he added. Neha told the police that on Saturday, Sheetal left home saying that she was going to Ahar village to shoot for an upcoming album. According to her, Sheetal met Irsana native Sunil around six months ago when she worked at his hotel there.

"When Sheetal discovered that Sunil was married and had two children, she left her hotel job and started pursuing her modelling career. But Sunil kept chasing her. At midnight on Saturday, Sheetal contacted me over a video call and said that she had finished her work and would reach home soon. She mentioned that Sunil had reached the place where she was shooting and assaulted her," Neha told the police.

"She (Sheetal) said Sunil was forcibly trying to take her with him. The call got disconnected midway. After that, I kept trying to connect but could not. On Sunday morning, I got to know that Sunil's car was found in a canal," Neha added in her complaint.

Focus on water conservation & improving irrigation efficiency: CM Saini asks officers

Instructing the officers concerned to focus on enhancing water conservation and improving irrigation efficiency, Haryana Chief Minister, Nayab Singh Saini on Monday said that the State Government is taking firm and determined steps to strengthen the irrigation and water infrastructure. Under this initiative, five major projects under the Irrigation and Water Resources Department are being implemented, each with an investment exceeding Rs. 100 crore.

These projects aim to enhance water conservation and improve irrigation efficiency, he added while presiding over a review meeting of various pivotal projects of the Irrigation and Water Resources Department in Chandigarh.

Issuing strict directions, he said that there must be no unnecessary delay in preparing engineering drawings. Delays in drawing approvals hinder project implementation, he said.

Saini further said that strict action will be taken against officers responsible for such delays. Besides this, he also directed that special attention be paid to maintaining quality in the projects, stating that no compromise on quality would be tolerated. He said that a new parallel lined channel (PLC) from Dadupur to Hamida Head and the modernization of the WJC is being carried out with an investment of Rs. 274.87 crore.

The objective of this project is to reduce seepage losses from the Hathnikund Barrage during the non-monsoon period. So far, 64.5 percent of the work has been completed, with a target to finish by March 2026, he said.

He stated that the reconstruction of the augmentation canal up to the WJC Branch (75.25 km) is being undertaken at a cost of Rs. 383 crore, with 80 percent of the work completed and expected to finish by June 2025. Similarly, the lining and remodeling of the PD Branch (from Munak to Khubru Head) is underway at a cost of Rs. 197.80 crore, which includes concrete lining over 145.25 kilometers.

We must focus on making cities vibrant, sensitive & self-reliant: Haryana CM

Stating that urban development must not be limited to infrastructure like buildings and roads but must also focus on making cities vibrant, sensitive, and self-reliant, Haryana Chief Minister Nayab Singh Saini on Monday said that mayors, as the first citizens, play a significant role in ensuring the development and progress of the cities. Mayors implement government policies and schemes on the ground and understand the aspirations of citizens, and work to resolve their issues. In the vision of local self-governance, mayors are akin to the backbone, Saini added while addressing the 115th meeting of the All India Mayor's Executive Council held in Panchkula.

He said that in Haryana, the budget allocated to Urban Local Bodies has increased from Rs. 1,693 crore in 2014-15 to Rs. 5,666 crore in 2025-26. Four Metropolitan Development Authorities have been established, and cities like Faridabad and Karnal are being developed as Smart Cities.

Under this initiative, 45 projects worth Rs. 930 crore are underway in Faridabad, while 122 projects worth Rs. 927 crore are ongoing in Karnal. Besides this, 2417 unauthorized colonies have been regularized, and development works worth Rs. 1,000 crore are being carried out in newly authorized colonies, shared Saini.

The Chief Minister said that under the AMRUT Mission, Rs. 2,930 crore has been spent so far. Of the target to deploy 375 electric buses, 50 have already started operations across 9 cities, and 450 more buses will be procured by 2026 under the PM-eBus Seva Scheme.

He further said that 21,431 houses have been constructed under the Pradhan Mantri Awas Yojana (Urban), and 11,412 houses are under construction. Under the Mukhyamantri Shehri Awas Yojana, 15,256 families across 14 cities have been allotted plots.

A watershed moment in India's policy and politics

The notification of Census 2027 marks a significant step towards building an inclusive India

On June 16, 2025, Union Home Minister Amit Shah officially notified the commencement of India's 16th national Census — marking the eighth since independence — setting in motion what may become the most significant demographic exercise in the country's history. But this is not just another count of people and households. For the first time, the Indian Census will include caste enumeration, a move with potentially transformative implications for policymaking, governance, and political discourse. Originally scheduled for 2021, Census 2027 comes after a six-year delay, primarily due to the COVID-19 pandemic and its prolonged disruptions to field operations. In addition, administrative hesitations and political sensitivity around the issue of caste enumeration contributed to the postponement. Bihar's caste-based survey in 2023 laid the groundwork for this national shift. The findings there challenged long-held assumptions and triggered a broader national conversation.

As states like Maharashtra, Odisha, and Karnataka began seeking their own surveys, pressure mounted on the Centre to rise above political hesitation. The inclusion of caste data was a matter of heated debate over the past few years, with the opposition consistently demanding a caste-based Census to better understand socio-economic disparities and frame more targeted welfare policies. The Modi Government, on its part, had long resisted these demands — arguing that caste enumeration could be divisive and logistically challenging. However, growing pressure from regional parties, and even some within the NDA fold — especially in light of Bihar's caste survey in 2023 — left the Centre with few choices. The entire exercise will be conducted digitally for the first time. About 34 lakh enumerators and 1.3 lakh functionaries will be deployed, armed with mobile applications to ensure efficiency, accuracy, and real-time data management. A significant feature of Census 2027 will be the option for self-enumeration via digital platforms, empowering citizens to directly participate in the data collection process. The inclusion of caste data marks a paradigm shift.

For decades, Indian policymakers have been working with incomplete caste data — largely based on the 1931 Census, the last time caste details were officially recorded. This outdated picture has led to ambiguous policy formation, skewed welfare targeting, and inconsistent reservation frameworks. Political parties across the spectrum — especially the opposition — have argued that affirmative action and socio-economic schemes cannot be equitable without accurate caste data. Caste influences access to education, employment, healthcare, and land ownership. A detailed Census would help craft data-driven social justice policies, recalibrate reservation quotas if needed, and direct resources more effectively. Census 2027 will be a social mirror. For the first time, policymakers and citizens alike may have access to reliable, granular caste data. This opens new possibilities for targeted welfare, social reform, and participative governance. Yes, challenges abound — data privacy, political misuse, administrative errors — but the potential rewards are immense.





Give blood, give hope: Together we save lives

The theme for this year's World Blood Donor Day — "Give blood, give hope: together we save lives" — beautifully captures the essence of what it means to donate blood. It is more than a medical act; it is a gift of life, a symbol of solidarity, and a powerful expression of compassion. Blood donors are unsung heroes whose quiet generosity sustains the very heartbeat of healthcare systems across the world. My own journey with blood donation began early, shaped profoundly by my father's long battle with a bleeding disorder. He needed countless transfusions throughout his life, but none as urgent as during a sudden, life-threatening brain haemorrhage. Emergency surgery saved him — but only because blood had already been donated, stored, and made available. I will never forget the wave of gratitude I felt for the strangers who had given without knowing him. Each unit of blood was a thread in the web of life that held him together through the crisis. Every blood donor — whether a friend, family member, or total stranger — becomes part of a life-saving chain. Their selflessness is profound.

Blood transfusions are critical to modern medicine. They are essential for patients undergoing surgeries, dealing with trauma or accidents, suffering from severe anaemia or cancer, and managing inherited blood disorders like thal-

assaemia, sickle cell anaemia, and haemophilia. Often, a single donation becomes a bridge between life and death. Globally, two main donor categories exist: voluntary donors and family/replacement donors. The World Health Organisation has strongly advocated for a shift to voluntary, unpaid blood donations since 1997. These donations are considered the safest, most ethical, and most sustainable. In contrast, family or replacement donations — when someone donates blood specifically for a relative or friend — often involve emotional pressure and are less safe. They may even pose health risks, like Graft Versus Host Disease, when genetically similar donor blood attacks the recipient's body.

Recognising the importance of a safe and stable blood supply, India has taken significant strides. The Ministry of Health and Family Welfare, through the National Health Mission (NHM), supports blood banks with funds, equipment, manpower, and vehicles for collection and transport. The Government promotes free availability of processed blood to patients, aiming to reduce out-of-pocket expenses and encourage voluntary donation. A notable initiative is e-RaktKosh, a centralised blood bank management system developed by C-DAC. It links over 4,300 blood centres, allowing real-time access to blood availability, online donor registration, and nationwide coordination. Integrated with platforms like UMANG, e-Hospital, and Aarogya Setu, it improves efficiency, transparency, and reach. Civil society plays a crucial role as well.

Organisations like the Indian Red Cross Society, Blood Connect, and Sankalp India Foundation have created robust ecosystems to support voluntary donation. From 24/7 helplines to well-organised blood camps and emergency services, their efforts save thousands of lives annually. Despite this progress, India still falls short of WHO's recommended donation rate of 1 per cent of the population. In 2022, only 0.8 per cent donated, resulting in a shortfall of nearly a million units annually.

This gap is especially alarming given India's ageing population. By 2050, over 347 million Indians will be over the age of 60 — a demographic more likely to need transfusions, yet often ineligible to donate. To meet future demands, we must strengthen both infrastructure and public awareness. Advanced technologies like AI will help optimise donor screening and inventory management, but voluntary human participation remains irreplaceable. We must continue to educate, inspire, and mobilise citizens — especially the youth — to become life-long donors. We also draw strength from past pioneers like Leela Moolgaokar and Sir Upendranath Brahmachari, and present-day heroes like Kiran Sharma and Suresh Kumar Saini, whose dedication to voluntary blood donation has transformed lives. Their legacy is a reminder: when we give blood, we don't just donate a fluid — we offer hope, healing, and humanity. Let us honour their spirit. Let us give blood. Let us give hope. Together, we save lives.

The danger of nuclear war

Arms and ammunition seized in Manipur

In a massive haul of arms, the Manipur police and security forces recovered 328 guns, including sophisticated rifles, on the intervening night of June 13 and 14 in the five districts of the Imphal valley. This included 151 SLR rifles, 65 INSAS rifles, 73 unspecified rifle types, five carbine guns, two MP5 guns, 12 light machine gun rifles, six AK series rifles, two Amogh rifles, one mortar, six pistols, two barrels, an AR-15 gun and two flare guns, as well as hundreds of rounds of ammunition. The weapons were recovered after simultaneous search operations were conducted at different locations by joint teams of the Manipur police, the Central Armed Police Forces, the army and the paramilitary Assam Rifles. Since ethnic violence first broke out in Manipur on May 3, 2023, about 7,000 weapons and lakhs of rounds of ammunition were looted from police armouries. Since May 2023, more than 250 people have been killed and over 60,000 have been displaced. The state remains deeply divided, with physical and social barriers separating communities. Members of the Kuki-Zo community are unable to enter the capital, Imphal, while Meiteis cannot travel to the hill districts. A comprehensive approach, combining security operations with dialogue and reconciliation efforts, remains crucial for achieving lasting peace in the region.

Green Gold: India's Horticultural Leap into the Bioeconomy

Horticulture is a key catalyst to fuel a circular, green economy through its rich biodiversity, vast rural base, and untapped innovation potential. This transformation is not just an economic opportunity; it is a national imperative for sustainable prosperity

One of the most impactful elements of this transformation is the rapid progress in bioenergy. The ethanol blending rate in India has surged from 1.53 per cent in 2013-14 to 15 per cent in 2023-24, saving approximately ₹78,000 crore in foreign exchange and preventing the emission of 318 lakh tonnes of Carbon dioxide, according to the Ministry of Petroleum and Natural Gas (2024). This success has been driven by the development of second-generation ethanol refineries, which convert agricultural residues such as sugarcane bagasse, bamboo, and paddy straw into clean fuel,

thereby reinforcing circularity and climate sustainability in rural areas.

As India accelerates its transition to a low-carbon and resource-efficient economy, horticulture can be a critical driver in delivering scalable, inclusive, and market-aligned solutions within the bioeconomy framework.

Bridging the Gaps

Despite its potential, the integration of horticulture into the bioeconomy faces several structural and operational challenges that require urgent attention. One of the most pressing issues is the infrastructure gap. Many horticultural production zones lack access to reliable cold chains, pack houses, and processing units. According to NITI

Aayog (2023), post-harvest losses for perishable horticultural commodities can range from 15 to 20 per cent, primarily due to inefficient logistics, poor market access, and limited storage facilities. These losses not only reduce farmer incomes but also weaken the capacity of horticultural systems to support value addition and industrial linkage.

Equally concerning is the limited extent of value addition in horticultural produce. Most fruits, vegetables and other horticultural produce continue to be sold in raw or minimally processed forms, missing the opportunity for transformation into high-value bio-products such as bio-based packaging, plant-derived nutraceuticals, or fermented health foods. This not only restricts income potential but also prevents the sector from contributing fully to the bioeconomy's goals of waste reduction, innovation, and product diversification.

Financial constraints are another barrier. Bio-based enterprises, especially those involving new technologies or bioconversion processes, often require high initial investment, extended gestation periods, and market uncertainties. The lack of targeted financial instruments and risk-sharing mechanisms deter private sector investment, impeding the commercialisation and scaling of bio-based ventures. Moreover, the human capital base needed to power a bioeconomy is still in development. There is an urgent need for training

programs and capacity-building tailored to farmers, rural entrepreneurs, processors, and women stakeholders, enabling them to adopt new technologies and participate meaningfully in bio-economic value chains.

Finally, there are environmental and biodiversity risks that must be managed. Without adequate ecological safeguards, the aggressive exploitation of plant-based resources for bio-economic use may result in habitat loss, monoculture expansion, and disruption of local agro-ecological balances. As such, the growth of India's bioeconomy must be carefully regulated to ensure that it remains sustainable, resilient, and equitable.

Strategic Interventions: Building a Resilient and Inclusive Bioeconomy To unlock the full potential of horticulture in India's bioeconomy, a series of strategic and coordinated interventions are necessary. First and foremost, there is a need to strengthen policy and regulatory frameworks. These must be science-based, transparent, and harmonised across sectors to encourage innovation while safeguarding bio-sources and indigenous knowledge systems.

Policy clarity around biosafety, intellectual property, and benefit sharing will help create a conducive environment for investment and public trust. Second, investment in infrastructure and value chains must be prioritised.

Expanding rural cold chain networks, establishing decentralised processing units, and incentivising public-private partnerships for bio-manufacturing clusters can significantly reduce post-harvest losses and promote local-level value addition.

Models such as Rural Bioeconomy Parks, where processing, research, and training facilities co-exist, can serve as hubs for innovation and rural development. Third, there is a compelling need to promote innovation and skill development. Strengthening institutional support through Bio-AI hubs, biotech incubators, and mentorship programs like Bio-Saarthi can nurture a new generation of bio-entrepreneurs. Simultaneously, capacity-building programs aimed at women, youth, and marginalised farmers must be institutionalised to ensure inclusive participation in bio-economic growth.

Fourth, advancing climate-smart and sustainable practices in horticulture is critical. Promoting precision farming, water-saving technologies, integrated pest and nutrient management, and climate-resilient varieties will ensure that productivity gains do not come at the expense of ecological integrity.

The use of bio-inputs such as bio-pesticides and biofertilisers should be expanded, both for environmental reasons and to meet consumer demand for residue-free produce.

Finally, expanding access to finance and markets is vital for scaling the bioeconomy. Dedicated Bioeconomy Investment Funds, blended finance models, and credit guarantees tailored to bio-based enterprises can mobilise private capital and reduce the burden of early-stage risk.

Equally important is the need to develop robust market linkages for bio-based horticultural products, through branding, certification, export promotion, and integration into national and global supply chains.

The Road Ahead

India's bioeconomy offers a powerful pathway to achieve economic prosperity, ecological sustainability, and social equity. The horticulture sector, by its diversity, biological richness, and economic relevance, is well-positioned to become a cornerstone of this transformation. However, realising this vision will require deliberate action, through policy coherence, institutional innovation, infrastructure development, skill empowerment, and ecological stewardship.

As India moves into a decade defined by climate challenges and global sustainability commitments, a bioeconomy anchored in resilient and inclusive horticulture can not only meet domestic needs but also establish India as a global leader in green growth. By aligning scientific innovation with rural empowerment, and bio-based solutions with climate resilience, India can shape a future that is productive, equitable, and ecologically secure for generations to come.

Gender, Grit, and Altitude: Women on Everest Rewrite the Rules of Risk, Leadership, and Sustainability

AI-171 crash: A wake-up call for urban planning around airports

Some recent news stories highlighted that Mt. Everest peak is set to be reached by women thousandth time. However, the claim stands contested, as it has been argued that several women mountaineers scaled the peak successfully many times, like Lhakpa Sherpa, from Nepal, who did it ten times, a record for female climbers. However, according to the Himalayan Database, which tracks expeditions to the top of Everest, women climbers had scaled the peak 962 times, while men did so 11,955 times by the end of May 2025. While mountains are said to be conquered and narrated by men (Majastre 2009). 'Mountaineering landscapes have evolved as, and remain strongly masculinised concepts, and it has been, and still is, male-dominated' (Pomfret and Doran, 2015), and 'women mountaineers' continue to be marginalised by the overwhelming male-ness of popularised mountaineering (Hunt, 2019). No wonder that essentially masculine leadership traits shaped perceptions of who can succeed in a mountaineering space (Barratt 2010; Robinson 2008), and mountaineering leadership programmes have been imbued with a 'culture of competition, confidence, strength, toughness and proving worth' (Sharp, 2001). As a result, 'female mountaineering suffered structural oppression within that culture'. Nevertheless, the ratio of women getting to the top of the Everest is on the rise, which was one to 16 men in the 2000s, and two decades later, it is one to 10. In India, too, as of December 2024, 74 women scaled Mount Everest, among them were Arunima Sinha, the first female amputee, and very recently, Chhonzin Angmo, the first visually impaired woman.

Undoubtedly, under-representation has placed many aspiring women at a disadvantage as they fail to look up to role models for inspiration. Women mountaineers on climbing expeditions, also face practical difficulties with ill-fitted mountaineering outfits and equipment, generally designed for men, which not only cause discomfort and injuries, but also psychological handicaps such as 'self-doubt and anxiety about their abilities, which considerably influence their risk perception, and decision-making in challenging climbing situations'.

While, Billi Bierling, Director, of Himalayan Database, who herself climbed Everest in 2009, commented that 'when it comes to taking risks on the mountain, women are probably a little bit more conservative... if it is too dangerous, she won't take chances and go down, while a male climber, would still go'. However, a 2018 study (Dr Jenny Hall, York St John University, UK), contended that in an essentially masculinised environment, women mountaineers created a 'place of difference while negotiating risk, amounting to the legitimate 'other' forms of mountaineering. While gendered experiences of mountaineering offered insights into different



ways of confronting 'fear as a tactical emotion to negotiate positionality and coping strategies while experiencing risk', women mountaineers displayed unique qualities of leadership like cooperation, emotion, personal development, consensual decision-making and being relationship orientated. However, such differing traits have been often interpreted as their 'insufficient physical strength to endure the challenges of hard mountaineering' (Sharp).

While research in leisure studies and effectual geographies exploring women's experience in extreme sports like mountaineering is limited, particularly, in terms of how to effect influences the sentiment and emotional behaviours of women (Humberstone 2016; Warren 2016; Waitt and Clifton 2013; Evers 2004, 2006, 2009). Yet, there is a persistent belief that 'gender is consequential in adventure tourism'.

The void in such scholarship demonstrates an emphasis on masculinity in the high-altitude mountaineering' (Eger et al., 2021). A 2020 study that examined the empowering benefits of constraint negotiation for women mountaineers, reiterated that the 'mountaineering space was used to resist gendered expectations and gaining empowerment' (Harris & Wilson, 2007; Little & Wilson, 2005). Analysing responses from 321 female mountaineers, it dismissed the contention that 'women are passive victims of constraints, rather 'they are active agents, motivated to pursue mountaineering aspirations despite having identified barriers'.

As in the wave of social transformation in the 20th century, the sporting milieu and mountain activities got feminised (Galissaire, Mennesson, 2004), a comparative study of 2,211 climbers making their first attempt on Everest between 1990 and 2005, and of 5,324 climbers between 2006-2019, revealed that the summit success rates have almost doubled, both, for men and women, from 32.7 per cent of 214 women and 32.9 per cent of 1,702 men to 68.2 per cent of 548 women and 64.4 per cent of 2,860

men (Himalayan Database). Between 2006 and 2019, only 0.5 per cent of 548 women vs. 1.1 per cent of 2,860 men attempting Everest did not return home alive, which led to the conclusion that 'women are more likely to reach the summit and less likely to die'.

Now adventure tourism market which includes mountaineering has been projected to reach USD 345.6 Billion this year and is expected to expand to USD 745.7 Billion by 2035, representing a compound annual growth rate (CAGR) of 8 per cent from 2025 to 2035. India is also slated to grow with a CAGR of 8 per cent during the period, and the tourism economy is targeted to reach USD 3 Trillion by 2047.

While, women, both, as mountaineers and inhabitants of mountainous regions, could contribute significantly to micro and macro economies. As primary managers of mountain resources and participants in local economies, particularly in agriculture, animal husbandry, and tourism, they play a vital role in generating local livelihoods and ensuring food security and biodiversity. Labour market activities like arranging homestays, crafts, and guiding will also have a broader impact on the country's overall development. Women as mountaineers can boost entrepreneurship by promoting eco-friendly mountain-related industries, sustainable tourism models, and high-altitude scientific research.

As many environmentalists and development economists red-flagged the issue of the 'commodification' of mountains, International Mountain Day 2024, rightly focused on mountain solutions for a sustainable future. While, the UN Environment, Executive Director, Erik Solheim, highlighted the role of 'women in protecting the mountain ecosystems'. Since, mountains form the most vulnerable part of the natural ecosystem, women with adequate financial and institutional support could act as change agents in building up sustainable economy and ecosystems.

The Air India AI-171 crash near Ahmedabad airport has left behind more than just wreckage. It has left families devastated, careers cut short, and a city in grief. Amid all that's being said about aircraft performance, weather, and pilot decisions, a quieter but harsher truth is coming to light — this tragedy on the ground (at the medical college hostel) could have been avoided if proper building norms and smarter urban planning around airports had been followed. Past disasters have already shown how densely populated areas near runways can turn aviation accidents into large-scale tragedies. In 2020, Pakistan International Airlines Flight 8303 crashed into Karachi's Model Colony, a crowded residential area just short of the runway, killing 97 people. In 2012, Dana Air Flight 992 fell into a suburb of Lagos, wiping out entire families.

Even in New York, American Airlines Flight 587 crashed over the Belle Harbor neighbourhood in Queens. The tragic crash of Air India flight AI-171, along with the examples above, brings into sharp focus the urgent need for better urban planning — especially within the 5-kilometre radius of major airports. The 5 km radius around airports has long been considered a sensitive zone — not necessarily because buildings within it are illegal or too tall, but because it is a critical safety zone for aircraft during take-off and landing, the most vulnerable phases of flight. Traditionally in India, during British rule, airports (unlike railway stations) were built far away from populated areas. For example, when Delhi's Safdarjung Airport and Palam Airport were built, there were very few settlements nearby — only a few army barracks around Safdarjung (now known as Lodhi Colony) and the old, sparsely populated villages of Mehram Nagar and Palam around Palam Airport. In those days, air crashes were more frequent, and placing airports away from populated areas was a deliberate step to avoid ground casualties. Even today, airports in tier-II towns are located at a fair distance from cities, although the growing urban sprawl is now fast approaching them as well. After independence, as India witnessed a massive surge in population and rapid urbanisation, cities began expanding in all directions. The airports that were once located far from residential and commercial zones gradually found themselves surrounded by growing urban settlements. With the rise in land demand, areas around airports have become highly sought after due to their excellent connectivity and strategic location, significantly pushing up real estate values. This led to high-density development near airport boundaries.

However, this unchecked growth brought with it serious concerns like constructing buildings near active flight paths not just from a flight safety perspective, but also from a security point of view. As

a result, managing construction and land use near airports became a critical issue, demanding a careful balance between urban development and the uncompromising need for aviation safety and security. Globally, aviation authorities, including India's DGCA and AAI, have issued detailed zoning maps for every major airport. There is a formal process to apply for height clearance of any structure. All international airports in India follow Obstacle Limitation Surfaces (OLS) — a set of 3D safety rules that make sure aircraft have enough space to climb and descend without danger. These OLS regulations, overseen by the Airports Authority of India (AAI) and DGCA, are not optional. They are strict safety norms. Structures within 5 km of a runway face the toughest height limits.

The hostel where the recent crash caused casualties was most likely within the permitted height as per AAI rules. But what often escapes attention is not just height, but the density of the human population in such areas. Even if buildings technically follow all safety norms, the presence of thousands of people living or working near a runway increases the risk in case of crashes, aborted landings, or engine failure during low-altitude flights. This is what makes the crash of AI-171 even more tragic. This raises a critical and timely question: Is it time to completely rethink how we plan our cities around airports — or even relocate airports themselves?

Hyderabad has already done it. The old Begumpet Airport was relocated to Shamshabad, about 24 km south of the city centre, to allow for future expansion and improved safety. With urban sprawl rapidly swallowing earlier remote zones, many airports in cities like Ahmedabad, Mumbai, and Chennai now find themselves trapped amid dense residential, institutional, and commercial structures.

The AI-171 crash should serve as a wake-up call. Not necessarily because rules were violated, but because the current model of reactive urban planning — where development chases growth without long-term thinking — is failing to safeguard lives. If airports are to expand safely along with cities, we may need to reimagine their place on the map.

That means moving older airports beyond city boundaries where possible, enforcing no-build or low-density zones around newer ones, and treating the 5 km airport radius not just as a regulatory guideline, but as a life-saving buffer zone. Urban planning must take into account not just real estate needs, but safety and long-term sustainability. The tragedy of AI-171 is not just a story of an aircraft gone wrong — it's also a story of a city that grew too close to danger.

"I am confident that in the time to come, our active partnership will touch new heights. Together, we will not only strengthen the progress of our two nations but also contribute towards building a peaceful

of Cyprus. The honour reflects the enduring India-Cyprus bilater-

al partnership and shared commitment to work together for the common vision for peace, progress and prosperity," the Ministry of External Affairs posted on X.

Cyprus' award brings the total tally of international honours conferred upon the prime minister to 23.

Modi noted the award was a recognition of India's age-old philosophy of "Vasudhaiva Kutumbakam" or "The World is one Family" that guides its vision for global peace and progress, an MEA statement said.

The prime minister embraced the honour as a renewed commitment to strengthening and diversifying the partnership between India and Cyprus and emphasised the award was a symbol of the unwavering commitment of the two countries to peace, security, sovereignty, territorial integrity and prosperity, the statement added.

Modi is in Cyprus on the first leg of his three-nation tour.

From Cyprus, he will travel to Canada to attend the G7 Summit and then to Croatia for a bilateral visit.

G7 summit opens in Canada with focus on trade, wars

When US President Donald Trump last came to Canada for a Group of Seven summit, the enduring image was of him seated with his arms folded defiantly as then-German Chancellor Angela Merkel stared daggers at him.

If there is a shared mission at this year's G7 summit, which begins Monday in Canada's Rocky Mountains, it is a desire to minimise any fireworks at a moment of combustible tensions.

The 2018 summit ended with Trump assailing his Canadian hosts on social media as he departed on Air Force One, saying he had instructed the US officials who remained in Quebec to oppose the G7 joint statement endorsed by the leaders of Japan, France, the United Kingdom, Italy, Germany and, of course, Canada.

"I have instructed our U.S. Reps not to endorse the Communiqué as we look at Tariffs on automobiles flooding the U.S. Market!" Trump posted on the site then known as Twitter.

This time, Trump already has hit several dozen nations with severe tariffs that risk a

global economic slowdown. There is little progress on settling the wars in Ukraine and Gaza and now a new and escalating conflict between Israel and Iran over Tehran's nuclear programme.

Add to all of that the problems of climate change, immigration, drug trafficking, new technologies such as artificial intelligence and China's continued manufacturing superiority and chokehold on key supply chains.

Asked if he planned to announce any trade agreements at the G7 as he left the White House on Sunday, Trump said: "We have our trade deals. All we have to do is send a letter, 'This is what you're going to have to pay.' But I think we'll have a few, few new trade deals."

At stake might be the survival of the G7 itself at a time when the Trump administration has sent mixed signals about whether the president will attend the November Group of 20 summit in South Africa.

What Trump opposed at the 2018 summit in Quebec wasn't just tariffs, but a focus on having alliances with a shared set of standards seeking to shape policies.

"The big dispute in Quebec were the references to the

rules-based international order and that's where that famous photo comes from," said Peter Boehm, Canada's counselor at the 2018 G7 summit in Quebec and a veteran of six G7 summits. "I think it gave everyone the idea that G7s were maybe not business as usual."

The German, UK, Japanese and Italian governments have each signalled a belief that a friendly relationship with Trump this year can reduce the likelihood of outbursts.

"Well, I have got a good relationship with President Trump, and that's important," UK Prime Minister Keir Starmer said Saturday as he flew to Canada. The UK prime minister said he will have a one-on-one meeting with Trump on the sidelines of the summit to discuss finalising a trade framework, though that does not appear in the White House schedule as an official meeting.

There is no plan for a joint statement this year from the G7, a sign that the Trump administration sees no need to build a shared consensus with fellow democracies if it views such a statement as contrary to its goals of new tariffs, more fossil fuel production and a Europe that is less dependent on the US military.

German court sentences Syrian doctor to life for crimes against humanity

A German court sentenced a Syrian doctor to life imprisonment for torture and war crimes in his Syrian homeland on Monday for killing two people and torturing nine in Syria between 2011 and 2012.

The Frankfurt Higher Regional Court also established the particular gravity of the guilt, which in practice virtually rules out early release after 15 years — as is often the case in Germany when people are sentenced to life imprisonment. The 40-year-old Syrian, who was identified as Alaa M. In line with German privacy rules, was placed in preventive detention, German news agency dpa reported.

In his verdict, presiding judge Christoph Koller described the actions of the accused in the military hospital in the Syrian city of Homs in the early stages of the civil war that began in 2011. He

said the doctor had sadistic tendencies and acted them out during the torture.

"Above all, the accused enjoyed harming people that seemed inferior and low-value to him," Koller said, according to dpa. During the trial, which lasted almost three and a half years, victims had described the most severe abuse, including beatings, kicks and the setting of wounds and body

parts on fire, dpa reported. Koller emphasised that without the willingness and courage of witnesses to share the details of their suffering the facts of the case could not have been clarified.

Mr Had lived in Germany for ten years and had worked as an orthopedic surgeon in several clinics, most recently in Bad Wildungen in northern Hesse.

UK PM appoints MI6 spy agency's first-ever female chief

Prime Minister Keir Starmer has announced the "historic" appointment of Blaise Metreweli as the first female chief of the UK's Secret Intelligence Service, commonly known as MI6, in the 116-year history of the organisation.

Commonly referred to as 'C', the international spy agency's chief has operational responsibility for MI6 and is the only publicly named member of the organisation, accountable to Foreign Secretary David Lammy.

Metreweli, 47, has been promoted from current role as Director General, or 'Q', responsible for technology and innovation in MI6 and has previously held a director-level role at MI5 — the UK's domestic security service.

"The historic appointment of Blaise Metreweli comes at a time when the work of our intelligence services has never been more vital," Starmer said

on Sunday. "The United Kingdom is facing threats on an unprecedented scale — be it aggressors who send their spy ships to our waters or hackers whose sophisticated cyber plots seek to disrupt our public services," he said.

Metreweli will succeed Sir Richard Moore, who leaves the service in the autumn later this year.

"I'd like to thank Sir Richard Moore for his dedicated service and I know Blaise will continue to provide the excellent leadership needed to defend our country and keep our people safe — the foundation of my Plan for Change," added Starmer.

The new spy chief expressed her pride and honour in leading the security service which she has been a part of since 1999 as a career intelligence officer, having joined the Security Service as a case officer. "MI6 plays a vital role — with MI5 and GCHQ [Government Communications Headquarters]

— in keeping the British people safe and promoting UK interests overseas. I look forward to continuing that work alongside the brave officers and agents of MI6 and our many international partners," said the new 'C'.

Metreweli, who studied Anthropology at Pembroke College, Cambridge University, has spent most of her career in operational roles in the Middle East and Europe.

"With a wealth of experience from across our national security community, Blaise is the ideal candidate to lead MI6 into the future," said her boss David Lammy.

"At a time of global instability and emerging security threats, where technology is

power and our adversaries are working ever closer together, Blaise will ensure the UK can tackle these challenges head on to keep Britain safe and secure at home and abroad," he said.

"Every day, our intelligence services work behind the scenes to protect our national security and compete with our adversaries.

"That's why I am proud that we are investing an extra GBP 600 million in our intelligence community so they can continue to defend our way of life," added Lammy.

Metreweli will be the 18th chief of MI6 when she takes charge from Moore.

"I am absolutely delighted by this historic appointment of my colleague, Blaise Metreweli to succeed me as 'C'. Blaise is a highly accomplished intelligence officer and leader and one of our foremost thinkers on technology. I am excited to welcome her as the first female head of MI6," said the outgoing 'C'.

Cabinet Secretary Christopher Wormald said the new C's experience and leadership in the intelligence community will help MI6 protect the "foundation of our national security and project our interests overseas".

"Blaise will be an excellent chief, who will embody the values of the Service and act as a fine role model to its staff. I would also like to thank Sir Richard Moore for his excellent leadership of the Service over the past five years and his contribution to UK national security during that time and over his long career," said Wormald.

MI6 has been famously projected in Ian Fleming authored James Bond novels and the related Hollywood film franchise, where Dame Judi Dench has taken on the role of 'C' referenced as 'M' in the fictional scenario.

Meanwhile, Metreweli's current role in charge of tech at the spy agency is depicted as 'Q' in the books and films.

Ireland prepares to excavate 'mass grave' at mother and baby home

Officials in Ireland began work Monday to excavate the site of a former church-run home for unmarried women and their babies to identify the remains of some 800 infants and young children who died there.

The long-awaited excavation at the former Bon Secours Mother and Baby Home in Tuam, County Galway in western Ireland, is part of a reckoning in an overwhelmingly Roman Catholic country with a history of abuses in church-run institutions.

The home, which was run by an order of Catholic nuns and closed in 1961, was one of many such institutions that housed tens of thousands of orphans and unmarried pregnant women who were forced to give up their children throughout much of the 20th century.

In 2014, historian Catherine Corless tracked down death certificates for nearly 800 children who died at the home in Tuam between the 1920s and 1961 — but could only find a burial record for one child.

Investigators later found a mass grave containing the remains of babies and young children in an underground sewage structure on the grounds of the home. DNA analysis found that the ages of the dead ranged from 35 weeks gestation to 3 years.

Israel condemns black partition walls around its pavilions at Paris Air Show

Israel's Ministry of Defence has condemned the erection of black partition walls around its defence industry pavilions at the Paris Air Show, calling the move "outrageous and unprecedented" and demanding an immediate reversal by French authorities and event organisers.

The walls appeared overnight ahead of the air show's opening Monday, visually isolating Israeli booths from dozens of other international exhibitors.

Israeli officials say the move followed a last-minute

demand from organisers to remove offensive weapons systems from display — a request they rejected.

"The French are hiding behind supposedly political considerations to exclude Israeli offensive weapons from an international exhibition — weapons that compete with French industries," the ministry said in a statement Monday, calling the action "ugly and improper".

A French appeals court ruled Friday against activist groups who sought to block Israeli companies from participating in the show due to the war in Gaza.

Despite the legal green light, Israel says it was effectively censored.

Sylvain Pavillet, a lawyer working with the air show organisers, said the final decision on who is allowed to exhibit lies with the French government, not the show itself.

"The fair is not the one who decides which countries are allowed to go to the show or not," he told The Associated Press. "That decision belongs to the government. We are not a state. We are a commercial company."

The Paris Air Show, held at Le Bourget Airport, is one of the world's largest and most prestigious events for the aerospace and defence industry.

Volodymyr visits Austria for first time since Russia's full-scale invasion of his country

Ukrainian President Volodymyr Zelenskyy is visiting Austria on Monday in his first trip to the European Union member country since Russia's full-scale invasion of Ukraine in 2022.

Austria is famously neutral — a stance it declared in 1955 after World War II — and Vienna has come under heavy criticism since the start of the Russia-Ukraine war for maintaining ties with Moscow.

Ukraine's air force said Russia fired 138 strike and decoy drones at Ukraine overnight, mainly at the eastern Donetsk region. Of those,

125 were either intercepted or jammed, while 10 reached

their targets. Eight others caused damage as falling debris.

Zelenskyy was scheduled to meet with Austrian President Alexander Van der Bellen and Chancellor Christian Stocker, and the two presidents were set to hold a news conference later Monday.

This is Stocker's first high-profile visit from a foreign dignitary since he took office in March at the head of a previously untried three-party coalition after a record five-month wait for a new administration. Zelenskyy's wife, First Lady Olena Zelenska and Doris Schmidauer, Van der Bellen's spouse, will also host a discussion about the role of women in promoting peace and security during the trip.

A guide to what Juneteenth holiday is and how to celebrate it

It was 160 years ago that enslaved people in Galveston, Texas, learned they had been freed — after the Civil War's end and two years after President Abraham Lincoln's Emancipation Proclamation.

The resulting Juneteenth holiday — its name combining "June" and "nineteenth" — has only grown in one-and-a-half centuries. In 2021, President Joe Biden designated it a federal holiday — expanding its recognition beyond Black America. This year will be the first Juneteenth under President Donald Trump's second administration, which has banned diversity, equity and inclusion initiatives, or DEI, in the federal government. This

has included removing Black American history content from federal websites. Trump officials have also discouraged some federal agencies from recognising other racial heritage celebrations.

Still, many people anticipate getting Juneteenth off work. There are a plethora of street festivals, fairs, concerts and other events planned throughout the week leading into the holiday. But with the current political climate, some may wonder if their company will honour it.

"I don't think anyone should be intimidated or obligated into not celebrating the day," said Marc Morial, president and CEO of the National Urban League. "I've not heard of anyone being denied. I think it would be absolutely reprehensible." People who

never gave the occasion more than a passing thought may be asking themselves, is there a "right" way to celebrate Juneteenth?

For beginners and those brushing up on history, here are some answers:

Is Juneteenth more of a solemn day of remembrance or a party? It depends on what you want. Juneteenth festivities are rooted in cookouts and picnics. Originally celebrated as Black Americans' true Independence Day, outdoor events allowed for large, raucous reunions among formerly enslaved family, many of whom had been separated.

The gatherings were especially revolutionary because they were free of restrictive measures, known as "Black Codes," enforced in Confederate states. Codes con-

trolled whether liberated slaves could vote, buy property, gather for worship and other aspects of daily life.

Last year, the White House kicked things off early with a concert on the South Lawn for Juneteenth and Black Music Month. The atmosphere was primarily festive with Vice President Kamala Harris, the first Black vice president, dancing on stage with gospel singer Kirk Franklin.

Plans for a Juneteenth event or proclamation this year have not been decided, according to the White House press office.

Others may choose to treat Juneteenth as a day of rest and remembrance. That can mean doing community service, attending an education panel or taking time off.

"The most important thing everyone should do is be able

to quickly answer the question 'What is Juneteenth?'" Morial said.

What if you've never celebrated Juneteenth?

Dr David Anderson, a Black pastor and CEO of Gracism Global, a consulting firm helping leaders navigate conversations bridging divides across race and culture, never did anything on Juneteenth in his youth. He didn't learn about it until his 30s.

"I think many folks haven't known about it — who are even my colour as an African American male. Even if you heard about it and knew about it, you didn't celebrate it," Anderson said.

"It was like just a part of history. It wasn't a celebration of history." For many African Americans, the farther away from Texas that they grew up

increased the likelihood they didn't have big Juneteenth celebrations regularly.

In the South, the day can vary based on when word of Emancipation reached each state.

What kind of public Juneteenth events are taking place?

Search online and you will find gatherings nationwide varying in scope and tone. Some are more carnival-esque festivals with food trucks, arts and crafts and parades. Within those festivals, you'll likely find information on health care, finance and community resources.

There also are concerts and fashion shows to highlight Black creativity. There will also be panels to educate about Juneteenth's history.

The National Park Service is

again making entry into all sites free on the holiday, according to its website.

Are there special Juneteenth decorations or foods?

The red, black and green African Liberation Flag, also known as the Pan-African flag, has historically been displayed at both Black History Month and Juneteenth celebrations. Red represents bloodshed and sacrifice of enslaved ancestors. Black symbolises Black people. Green represents richness of the land in Africa.

More people, however, have leaned into the Juneteenth flag created in 1997 by activist Ben Haith, who founded the National Juneteenth Celebration Foundation. Like the American flag, it is red, white and blue to indicate those freed are also Americans.

India-US to agree on early tranche of trade before July 9: Commerce Secy

Negotiations for the proposed India-US trade agreement are in good progress and the two sides are expected to agree on an early tranche of the pact before July 9, a top government official said on Monday.

"We are working on the early tranche and as you are aware that there is a date (July 9), before that we would like to conclude this early tranche," Commerce Secretary Sunil Barthwal told reporters here.

He said that Indian and the US teams are making visits to each other's country for trade talks. "We also visited the US twice. The US team also came here twice. There is good progress and we are hopeful that this will be done within the timelines," he added.

The US on April 2 imposed an additional 26 per cent reciprocal tariff on Indian goods but suspended it for 90 days till July 9. However, the 10 per cent baseline tariff imposed by America remains in place. India is seeking full exemption from the additional 26 per cent tariff. The US team was here from June 5 — 11 for the talks. The negotiations will continue both virtually and physically in the days to come.

When asked if the absence of the US Fast Track Trade Authority (also known as Trade Promotion Authority)



could delay the proposed trade pact with India, an official said that it is up to the US authorities to decide how to navigate its local regulations for the trade agreement with India. The next date of in-person negotiations on the BTA and its initial tranche is yet to be decided but both sides are engaging virtually without a break.

The US Fast Track Trade Authority is a special mechanism that allows the American President to negotiate trade agreements and present them to Congress for an up-or-down vote, without amendments or procedural

delays. According to think tank GTRI, since 2021, this authority has lapsed and has not been renewed and without this authority, any trade agreement negotiated by the US President is exposed to Congressional scrutiny, possible amendments, delays, or outright rejection.

On the FTA talks with the European Union, Additional Secretary in the Department of Commerce L Satya Srinivas said that the next round of negotiations will be held from July 7 in Brussels.

"There are some tracks, we are working together on this. Momentum has picked

up in the talks and frequency of meetings has gone up. Earlier negotiating rounds were held every quarter, but now we have reduced the time period between rounds," Srinivas said. The India-EU trade pact negotiations cover 23 policy areas or chapters, including Trade in Goods, Trade in Services, Investment, Sanitary and Phytosanitary Measures, Technical Barriers to Trade, Trade Remedies, Rules of Origin, Customs and Trade Facilitation, Competition, Trade Defence, among others.

"We have a large number of issues on which we are trying

to find a convergence so that we move towards the closure of the agreement," Srinivas said. India and the EU have agreed to conclude their FTA negotiations — which began in 2022 — by the end of this year.

On the India-UK trade pact, he said that the agreement is getting ready to be signed. The conclusion of the pact was announced on May 6. "Work on documentation is going on and legal scrubbing is in progress. The process will be completed within three months from the date of the completion of negotiations and we are sticking to that," Srinivas said.

Government to meet stakeholders to assess impact on India's trade


The Government is closely monitoring the situation arising from the Iran-Israel conflict, and a meeting with shipping lines, container firms, and other stakeholders will be held this week to assess the impact on the country's overseas trade and address any issue, a top official said on Monday.

Commerce Secretary Sunil Barthwal said that the impact of the war on India's trade will depend on how the situation unfolds over a period of time.

"We are watching the situation. We are also calling a meeting (this week) of all the shipping lines, the container organisations and the concerned departments, and stakeholders to understand from them that what are the kind of issues they are facing and how we can sort it out," he told reporters here. Exporters have stated that the war, if escalated further, would impact world trade and push both air and sea freight rates.

They have expressed apprehensions that the conflict is expected to impact movement of merchant ships from the Strait of Hormuz and Red Sea. Nearly two-thirds of India's crude oil and half of its LNG imports pass through the Strait of Hormuz, which Iran has now threatened to close.

This narrow waterway, only 21 miles wide at its narrowest point, handles nearly a fifth of global oil trade and is indis-

pensible to India, which depends on imports for over 80 per cent of its energy needs. According to think tank GTRI, any closure or military disruption in the Strait of Hormuz would sharply increase oil prices, shipping costs, and insurance premiums, triggering inflation, pressuring the rupee, and complicating India's fiscal management.

Meanwhile, Israel's June 14-15 strike on Houthi military leadership in Yemen has also heightened tensions in the Red Sea region, where Houthi forces have already attacked commercial shipping.

For India, this poses another serious risk. Nearly 30 per cent of India's west-bound exports to Europe, North Africa, and the US East Coast travel through the Bab el-Mandeb Strait, now vulnerable to further disruption, the GTRI has said. Indian export consignments gradually start-

ed moving through the Red Sea route but now again it may get impacted.

Cargo ships had gradually returned on Red Sea routes, saving them 15-20 days while moving to US and Europe from India and other parts of Asia. The present conflict that began with an attack on Israel on October 7, 2023 had brought cargo movement through Red Sea routes to a halt due to attacks by Houthi rebels on commercial shipping. After the US intervened with attacks on the rebels, the firing on commercial ships stopped.

Last year, the situation around the Bab-el-Mandeb Strait, a crucial shipping route connecting the Red Sea and the Mediterranean Sea to the Indian Ocean, escalated due to attacks by Yemen-based Houthi militants.

Sensex, Nifty rebound nearly 1 per cent on value buying

Shrugging off geopolitical concerns amid escalating tensions between Israel and Iran, stock markets rebounded by nearly 1 per cent on Monday following value buying in oil & gas and IT shares and gains in other Asian markets as Brent crude oil prices dropped.

The 30-share BSE Sensex jumped 677.55 points or 0.84 per cent to settle at 81,796.15 with 27 of its constituents ending in the green and three with losses. During the day, it surged 747.22 points or 0.92 per cent to 81,865.82. The 50-share NSE Nifty climbed 227.90 points or 0.92 per cent to 24,946.50.

Among Sensex firms, UltraTech Cement rose the most by 2.39 per cent. Tech Mahindra, HCL Tech, Tata Consultancy Services, Eterna, Asian Paints, Tata Steel and Kotak Mahindra Bank were among the gainers. Tata Motors, Adani Ports and Sun Pharma were the laggards.

"Despite ongoing geopolitical tensions between Israel and Iran, the market moved higher, supported by gains in large-cap stocks, as investors maintained their focus on long-term fundamentals in the time of volatile situations. Geopolitical developments in the Middle East are



likely to influence near-term market sentiment, with any signs of de-escalation being closely monitored," Vinod Nair, Head of Research, Geojit Investments Limited, said.

"Among sectors, oil and gas recorded strong gains, while the IT sector outperformed in anticipation of the upcoming US Fed policy meeting, which is expected to provide further clarity on the interest rate outlook," Nair added. The BSE midcap gauge jumped 0.93 per cent and smallcap index climbed 0.38 per cent.

All BSE sectoral indices ended higher. IT jumped 1.50 per cent, followed by BSE Focused IT (1.50 per cent), tech (1.35 per cent), oil and gas (1.22 per cent), realty (1.21 per cent), services (1.10 per cent) and consumer

durables (1.05 per cent).

In Asian markets, South Korea's Kospi, Japan's Nikkei 225 index, Shanghai's SSE Composite index and Hong Kong's Hang Seng settled in the positive territory. European markets were quoting in the green. US markets ended lower on Friday. Global oil benchmark Brent crude declined 0.81 per cent to \$73.63 a barrel. Wholesale price inflation (WPI) declined to a 14-month low of 0.39 per cent in May on easing prices of food articles and fuel.

"Despite mounting global uncertainty triggered by escalating tensions in the Middle East, Indian markets remained resilient," Sundar Kewat, Technical and Derivatives Analyst, Ashika Institutional Equity — Ashika Stock Broking part of Ashika Group, said.

FATF enhances focus to combat terror financing

Condemning the brutal Pahalgam terror attack in April, global watchdog Financial Action Task Force (FATF) on Monday said it has enhanced its focus on the effectiveness of measures countries have put in place to combat terror financing.

"Terrorist attacks kill, maim and inspire fear around the world. The FATF notes with grave concern and condemns the brutal terrorist attack in Pahalgam on 22 April 2025. This, and other recent attacks, could not occur without money and the means to move funds between terrorist supporters," the FATF said in a statement.



The FATF statement comes in the backdrop of Indian authorities highlighting Pakistan's persistent support for terrorism and its funneling of mul-

tilateral funds for arms procurement. According to sources, such action by Pakistan warrants that the country be put in the "grey list" of the FATF.

WPI inflation dips to 14-month low of 0.39 pc in May

Wholesale Price Inflation (WPI) declined to a 14-month low of 0.39 per cent in May on easing prices of food articles and fuel, and experts said geopolitical tensions could push up prices. WPI-based inflation was 0.85 per cent in April. It was 2.74 per cent in May last year.

In a statement, the industry ministry said the inflator in May is in positive zone primarily due to "increase in prices of manufacture of food products, electricity, other manufacturing, chemicals and



chemical products, manufacture of other transport equipment and non-food articles".

According to the WPI data, food articles saw a deflation of 1.56 per cent in May, against a deflation of 0.86 per cent in

April, with vegetables, onion, potato and pulses seeing negative inflation. Deflation in vegetables was 21.62 per cent in May, compared to 18.26 per cent in April.

Fuel and power, too, saw a deflation of 2.27 pc in May, compared to a 2.18 per cent inflation in April. Manufactured products, however, saw positive inflation at 2.04 per cent, compared to 2.62 per cent in April. The Reserve Bank of India (RBI) mainly takes into account retail inflation while formulating monetary policy.

Data released last week showed retail inflation eased to over six-year low of 2.82 per cent in May mainly due to subdued food prices. The RBI this month cut benchmark policy interest rates by a sharp 0.50 per cent to 5.50 per cent amid easing inflation. The RBI has cut inflation projections for the current fiscal year to 3.7 per

cent from the earlier estimate of 4 per cent, as it expects core inflation to remain benign with the easing of international commodity prices.

The sub-4 per cent average retail inflation projection is the lowest in recent years.

ICRA Senior Economist Rahul Agrawal said the cooling in WPI was broad-based, with the food, non-food manufacturing, minerals, and fuel and power segments contributing to the dip in headline print between these months.

ICRA said crude oil prices have risen quite sharply in the ongoing month, following escalation of tensions between Israel and Iran.

PSG defeats Atlético Madrid 4-0 in Club World Cup

Fabián Ruiz and Vitinha scored in the first half and Champions League winners Paris Saint-Germain (PSG) opened Club World Cup play with a 4-0 victory over Atlético Madrid. PSG largely dominated Atlético at the Rose Bowl in its first match since trouncing Inter Milan 5-0 to win its first Champions League title on May 31. Senny Mayulu and Lee Kang-in scored against 10-man Atlético in the second half of the European powers' meeting in front of 80,619 fans at the site of the 1994 World Cup final. The matchup was one of the highest-profile games in the group stage of the first 32-team edition of the Club World Cup - and treble-winning PSG excelled under another spotlight.



Atlético's Clément Lenglet was sent off in the 78th minute with his second yellow card on a frustrating day that left Diego Simeone visibly furious at both the referees and his players' mistakes.

Ousmane Dembélé wasn't in uniform for PSG after reportedly injuring a quadriceps while playing for France on June 6. Gonçalo Ramos replaced Dembélé in Luis Enrique's only change to the starting lineup from the Champions League final.

Enrique wore shorts and a training shirt on the sideline while coaching PSG in 88-degree midday California heat (31 Celsius).

PSG controlled possession

early, and Ruiz capitalized atop the penalty area in the 19th minute. The Spanish midfielder long coveted by Atlético beat Jan Oblak with a clever strike into the far corner.

Vitinha followed with a goal in injury time off Khvicha Kvaratskhelia's second assist of the first half. Julián Alvarez appeared to answer for Atlético in the second half, but the goal was waved off after VAR determined Koke had fouled Désiré Doué in the buildup.

Alexander Sørloth horrifically missed an open net in the 82nd minute for Atlético. Mayulu iced PSG's victory five minutes later, and Lee converted a penalty on the final kick of the match. Atlético got a golden chance

to tie it in first-half injury time, but Gianluigi Donnarumma swallowed up Thomas Griezmann's hard shot in the box. Moments later, Vitinha slipped through the Atlético defense and scored on the break.

Takeaways
PSG looked remarkably sharp late in its taxing season, showing no sign of treating this tournament as an anti-climax. The champs are in good shape to advance from group play after winning their toughest group match on paper.

Atlético somehow looked more exhausted than its opponents, and it collected seven yellow cards that raise the danger of suspension down the road. Simeone's club will be favored in its next two matches, but will have less margin for error.

What they said
"I think that in this competition, we've set ourselves the goal to make history. We are entering a new chapter, and we need to show it's possible to reinvent ourselves. It's a good challenge. We need to keep fighting and working to win games. I was happy with the way we performed today," — Enrique

"The sending-off killed us. We knew it was going to be difficult, but for me, 4-0 is not fair. PSG are fair winners. Given their level, they were better. ... We have to push harder, like in the second half, when we were a different team.

A penalty shattered Palestinian WC dreams

An engrossing qualifying journey of 16 games and the obstacles of a war came crashing down in an instant for Oday Dabbagh and his Palestinian team.

Their legacy will long continue. Players left the field in tears in the immediate aftermath at the King Abdullah II Stadium in Amman, Jordan, last Thursday after their quest for a first appearance at a World Cup evaporated on a contentious penalty awarded deep in extra time. Fans looked on, stunned.

"It's very hard," Dabbagh, the team's star striker, said. "It was massive for us to get to the next stage - we prepared well, we had a positive atmosphere, and we had the fans with us. We gave everything, but it was gone in a moment."

Needing to win its last three Group B games to reach the playoffs for the last two of Asia's automatic spots at the World Cup, the number 101-



ranked team in the world beat Iraq in Basra in March, Kuwait in Kuwait City on June 5. Five days later, it was leading 1-0 against Oman in Jordan in the 97th minute.

The Palestinians had never been in a better position in qualifying for a World Cup. Then Oman was awarded, and scored, a penalty to make it 1-1 in the last real act of the game.

Not long after the dejected players had picked themselves up, the Palestine Football Association (PFA) made an official complaint to soccer's world governing

body, FIFA, about the penalty. It didn't change the fact, however, that the long road trip was over.

"We tried to put smiles on the faces of Palestinians amid their great pain," head coach Ihab Abujazar said. "The heroic players are our pride and glory, a symbol of all that is beautiful in the Palestinian nation."

Playing Away
It may have been different if the Palestinian team, admitted into FIFA in 1998, was able to play home games in front of its fans in Gaza or the

West Bank in the third round of qualifying. The Israel-Hamas war meant that couldn't happen. And so the many of the team's home games have been taking place in the nearby Jordanian capital of Amman, home to a large community of Palestinians.

"It is easier to play in your home," Dabbagh, who helped Aberdeen win the Scottish Cup last month, said. "But the circumstances there are so difficult so we choose to play in Amman as it is close to Palestine, the people are the same, and we have a lot of fans there."

There's been no domestic soccer in the Palestinian territories since the war started in 2023. Hundreds of athletes are among the more than 55,000 Palestinians killed in the conflict and sports facilities have been destroyed.

"Everything that goes on makes us all sad," Dabbagh said. "As players, we try to focus on football during the games, but we use what is happening as motivation to bring happiness to the people of Palestine."

HEGERBERG'S LEADERSHIP HIGHLIGHTED AS KEY TO EURO 2025 CHALLENGE

The leadership of Norway captain Ada Hegerberg was highlighted on Monday as key to the two-time former title holder heading into the Women's European Championship next month.

Hegerberg, the 2018 Ballon d'Or winner, headed a 23-player squad picked by coach Gemma Grainger for the July 2-27 tournament in Switzerland. "One of Ada's biggest strengths is how authentic she is," Grainger said Monday with Hegerberg sitting next to her at a squad announcement event.

"Ada will always tell me what she thinks," the coach said, adding "then you get to places a lot quicker" even if it involved "many uncomfortable conversations."

Hegerberg quipped with a smile: "That is what you get." Norway was European champion in 1987 and 1993 and is a four-time beaten finalist, most recently in 2013 when the team had a teenage forward line of Hegerberg and Caroline Graham Hansen.

The two storied veterans and former Champions League winners — Hegerberg at Lyon and Hansen at Barcelona — with a combined 100 national-team goals are the biggest stars in the Euro 2025 squad.

The 30-year-old Hegerberg has 49 goals despite persistent injuries, and a five-year exile from the team ahead of Euro 2022 that helped push the national federation to treat women's soccer more



equally. Norway has not advanced from the group stage in the past two Euros editions though looks favored in the 16-nation draw for Euro 2025.

Norway plays in the opening-day game against host Switzerland on July 2 in Basel, faces Finland at Sion four days later and Iceland on June 10 in Thun.

"People can say there are none of the bigger names in our group," Grainger said. "You don't underestimate anybody."

Defender Maren Mjelde was picked for her fifth Euros at age 35 and with 179 national-team games. Four players left on standby include Liverpool forward Sophie Román Haug.

BCCI to conduct second bone test for age determination in junior cricket

In a significant move, the Board of Control for Cricket in India (BCCI) has decided to conduct an additional bone test at the junior level to ensure that no cricketer misses out on playing an extra season due to the "+1 factor" that is currently added to the calculation, which renders players ineligible by thinnest of margins.

As per the existing norms, a player undergoes a bone test for age determination via the TW3 method (test used for assessing bone age) and a +1 factor is added to determine his or her eligibility for the next season in the same age group.

However, with the rule change, a cricketer in the



Under-16 boys' category, will undergo a second bone test the following season to determine his eligibility to appear in the same age bracket in case the +1 factor rules him out in the previous year.

16 boys is 16.5 years and 15 years for U-15 girls competition.

"This means that the bone age of a player has to be 16.4 or below in the following season in male cricketers and 14.9 or below in case of females for participation," the source said.

To explain the rule change further, if a male U-16 player undergoes a bone test in the 2025-26 season and the result shows a bone age of 15.4 years, he would not need to undergo another bone test for the following season. Instead, a +1 factor is automatically added to their bone age.

In this instance, the player's bone age for the 2026-27 season would be arithmetically calculated to be 16.4 years, regardless of their actual bone growth, allowing them to participate in the U-16 tournament with a bone age of 16.4.

Similarly, if a player's bone age is determined to be 15.5 years or higher, the bone age automatically increases to 16.5 years or higher, making him ineligible for the U-16 tournament, since 16.4 is the final cutoff.

"It's possible that this arithmetical calculation does not accurately reflect a player's actual age, which could cause them to lose out on a year of eligibility," the source added.

In the case of U-15 girls, if a player tests 13.9 years this season, she will be eligible for the same category the next season with a bone age of 14.9.

However, if she tests at 14 or above this season, she can play this season but not the next one with cut off being 14.9.

England will hold edge over India, feels Dale Steyn

Mark Wood ruled out of at least the first three Tests due to injury.

"It is a pretty young team. Probably going to say that England are going to win the series but it's not going to come without a fight," Hayden said.



India's marquee women's ODI World Cup match against Pakistan will be held at the neutral venue of R Premadasa Stadium in Colombo on October 5, the ICC announced on Monday.

Colombo had to be added as a neutral venue according to the 'Hybrid Model' that was accepted for the men's Champions Trophy and beyond earlier this year after India refrained from travelling to Pakistan for the ICC event.

There were speculations whether ICC will slot an Indo-Pak round robin match, which is pretty much a feature in all global tournaments post terror attacks in Kashmir's Pahalgam where 26 Indian tourists were killed.

The military escalation from both sides had raised

doubts about India facing arch-rivals even at world events but ICC has cleared all doubts after the release of schedule on Monday.

India will kick off their campaign against Sri Lanka at Bengaluru on September 30, and will also face Bangladesh on October 26 at the M Chinnaswamy Stadium.

The venue losing hosting rights of

the matches after the recent stampede during the Royal Challengers Bengaluru victory celebrations.

India's contest against the Lankans is also the opening match of the ICC showpiece.

India, who are seeking their maiden title triumph, will lock horns with South Africa on October 9 and will meet defending champions Australia on October 12, and both the matches are at Visakhapatnam.

From there, India will move to Indore to face England on October 19 and then will proceed to Guwahati for the match with New Zealand on October 23.

"With the eight best teams in the women's game descending on India, alongside incredible venues and what promises to be record-breaking crowds, we are all looking forward to an unforgettable tournament," said

Jay Shah, the ICC Chairman, in a release.

However, the BCCI is yet to form the Local Organising Committee (LOC) which will be in charge of the running of the tournament.

Australia will start their campaign against New Zealand on October 1 at Indore, while the high-profile match against England in a rematch of the previous edition's final is scheduled to be played on October 22 in Indore.

Meanwhile, Pakistan will play all their matches in Colombo as per the hybrid model.

Apart from the match against India, they will also play against Bangladesh (October 2), Australia (October 8), England (October 15), New Zealand (October 18), South Africa (October 21) and Sri Lanka (October 24) at the Premadasa Stadium.

The first semifinal is scheduled for October 29 either at Guwahati or Colombo depending on Pakistan's progress in the tournament.

The second semifinal will be held at Bengaluru on October 30, while the final will be held at Bengaluru or Colombo on November 2 as per Pakistan's standing in the event.

India are hosting this global event for the first time since 2013, and all the eight teams will play each other in a round-robin format, with the top four entering the semifinals.

Apart from hosts India, the

Aussies, England, New Zealand, South Africa and Sri Lanka achieved direct qualification to the World Cup while Pakistan

and Bangladesh entered the tournament through the Qualifiers at Lahore earlier this year.

D Deepesh, Pushpak drafted into India U19

Deepesh and Naman Pushpak have been drafted into the India men's U19 squad for the upcoming tour of England as replacements for injured Aditya Rana and Khilan Patel, respectively, the BCCI said on Monday.

The tour is scheduled to take place from June 24 to July 23. The Junior Cricket Committee has named D. Deepesh and Naman Pushpak as replacements for Aditya Rana and Khilan Patel, respectively, for the upcoming India U19 tour of England," the BCCI said in a statement.

Both Deepesh and Naman were part of the standby players' list for the tour.

Aditya sustained a stress fracture in his lower back, while Khilan suffered a stress reaction in his right leg during the ongoing high-performance camp at the BCCI Centre of Excellence.

The team will be led by Ayush Mhatre, who shone for Chennai Super Kings in IPL 2025. The tour comprises a 50-over warm-up match at Loughborough University, followed by a five-match Youth One-Day series in Hove, Northampton and Worcester.

Two multi-day matches against England U19 will be played at Beckenham and Chelmsford respectively.

Wicketkeeper-batter Abhigyan Kundu has been appointed as the team's vice-captain.

FEI cancels at least 24 equestrian events in India

In a development that will hurt the riders and the development of equestrian sport in the country, at least 24 domestic and international tournaments have been cancelled due to non-payment of dues to the world governing body, FEI, by the Equestrian Federation of India (EFI).

It has been learnt that EFI was supposed to pay about Rs 27 lakh to the FEI officials as remuneration and allied charges for various events held between January and March 2025. However, the federation's account stands frozen due to the infighting among the warring factions, leading to non-payments of dues, forcing FEI to take off the events from the calendar.

The EFI also needs to settle accounts for unpaid salaries, various costs of tournaments hosted in the past year and other expenses running into almost two crore.

"EFI was supposed to pay remuneration to FEI officials for various Eventing, Show Jumping and Dressage events held in Delhi, Meerut and Jaipur. However, the bank has frozen the account due to different factions within the Federation claiming operational access," an EFI source said.



"It is embarrassing and the athletes are the biggest losers here, but that is the situation. The sports ministry has been apprised of the latest infighting," the source added.

What led to the mess?

The EFI was supposed to hold its election in September 2023 but litigations delayed the polls, following which a Committee of Administrators (CoA) was appointed by the Delhi High Court on May 21, 2024.

The decision was challenged and, on May 29, the court rein-

stated the Executive Committee of the EFI as an interim measure, keeping in mind the participation of Indian riders in the Paris Olympics. The EC, in a meeting on April 11, 2025, without the presence of court-appointed observer SY Quraishi, decided to suspend Colonel Jaiveer Singh as secretary general of the Federation. Quraishi directed the EC to get the order approved from the court before its implementation.

Colonel SS Ahlawat moved the court on May 5, seeking

approval. However, the application was rejected on May 7 since the decision was not conforming to the law.

"The fact that removed the secretary general notified the development to FEI and also claimed the ownership of the bank account before getting the approval of the court. The bank then froze the account due to multiple stakes," the source said.

When contacted, Col Jaiveer Singh confirmed the development.

"If you read the EFI statutes,

the constitution says that the General Assembly, by a two-thirds majority of votes, can terminate from the Federation any member of the Executive Committee, Selection Committee, Athletes' Commission and other sub-committees for gross misconduct or for activities contrary to the interests and objectives of the EFI.

"They decided on my removal without calling the General Assembly. It had to be rejected by the. Moreover, they attached the plea with an old

case that does not stand now," Jaiveer said.

FEI Secretary General on February 11, 2025, had written to the EFI that it was cancelling the Eventing event that was to be held on February 24-28 in Meerut. EFI was supposed to clear the dues by February 7 but due to non-payment, FEI proceeded with the cancellation of the event. FEI made it clear that EFI will have to pay in advance for future events, and failure to comply will result in cancellation of future events.

Till June 16, 2025 EFI has lost 12 events, including a workshop on Para Dressage, and is set to lose 12 more till mid-October.

These include the Para Dressage World Challenge in Bengaluru (Oct 10-12), World Dressage (Oct 8-9 in Bengaluru), and FEI Jumping (CDS Jul 24-27 in Bengaluru).

Asked how come EFI has not paid salaries and other expenses from the past when the bank account froze only recently, the source said, "You are right. The AGM held on August 18, 2024, had approved the budget and calendar, but the EC chose not to pay it."

"We really need an intervention of the Sports Ministry here. Unless they do something about it and fresh elections are held, the mess is not going to clear."
